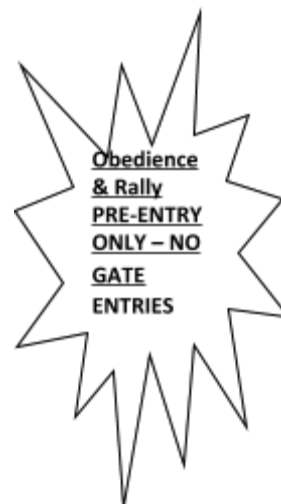

Dogs excused or disqualified under said policy, will be excused from the remainder of the events and asked to leave, without refund of entry fees.

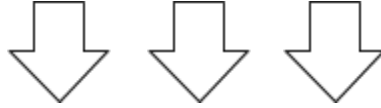
