Sunday, December 16th

AHBA Duck Arena Trial – Course 1

LOCATION: University of Wisconsin- River Falls, Lab Farm #1 Horse Arena. 1475 S. Wasson Lane, River Falls, WI 54022

Directions from the Twin Cities or Eastern WI:

I-94 to WI-35 (Exit #3 from the Twin Cities). Stay on WI-35 for approximately 10 miles. Turn Right at the first stop light. In approximately 200ft, turn left onto S. Wasson Lane. The farm is on your right. Go to the end of driveway, the horse barn is on your left.

Coming from the Western/ Southern WI:

From WI-35/29: Take a right onto Cemetery Rd. At the round-about, take the 4th exit onto S. Wasson Lane. The farm will be on your left. Go to the end of driveway, the horse barn is on your left.

From WI-65: At the round-about, take the Cemetery Rd exit. At the next round-about, take the 1^{st} exit onto S. Wasson Lane. The farm will be on your left. Go to the end of driveway, the horse barn is on your left.

Saturday Dec. 15th

• **ASCA TRIAL**: Check in 9 a.m. to 9:15 a.m. Handler's meeting at 9:30 a.m. ASCA trial starts immediately after handler's meeting. Limited entries available. ASCA rules and regulations will apply. Head per run: 5 ducks.

FEES: \$20.00 pre-entry \$25.00 day of entry

DUCK-OFF EVENT: Please join us for this fun event. All proceeds from the "Duck Off" will go to Aussie Rescue. This is a non-sanctioned event with the sole purpose of having fun and supporting a great cause. Special awards will be given for first place in all classes.

FEES: \$20.00 Pre-entry or day of entry \$15.00 Day of entry only, for an additional run with same handler/ dog or handler/handler team

After completion of ASCA duck trial and awards, the

December Duck Off will begin!!!!!!

Lunch Break will be at the judge's discretion

Available Classes:

- Advanced with Dog: For dogs that have an advanced title in any type of livestock, in any organization.
- <u>Intermediate with Dog:</u> For dogs that have an open/intermediate title in any type, of livestock in any organization.
- <u>Started with Dog:</u> For dogs that have a started title or no titles in, any type of livestock in any organization.
- <u>Novice Handler</u>: Open to teams of 2. No dog is allowed. For entrants who have no livestock experience or have never moved ducks before.
- <u>Advanced Handler</u>: Open to a team of 2. No dogs allowed. For entrants who have livestock experience or have moved ducks before.
- <u>Junior Handler</u>: Open to a team of 2 or an individual junior with an adult. Ages 12 and under. No dogs allowed.

<u>Description</u>: The course will consist of obstacles set up all within the arena. Each obstacle will be worth a pre-determined amount of points. Each team (with dog or without dog) will have 4 minutes to complete as many obstacles as possible, in any order they wish, to accumulate points. Each obstacle may only be taken twice. The team will be signaled at 4 minutes to try and complete the "Gamble." The Gamble will be 3-4 obstacles in a set order of completion with a handler's line, based upon which class they are entered in. Teams will have one minute to complete to the gamble. During the gamble, each obstacle within the gamble will be worth double points. Obstacles in the gamble may be taken during the opening, but not in consecutive order, or you forfeit your Gamble.

The winner of each class will be decided by whoever earns the most points during their run. In the event of a tie, time will be the tie breaker. If both time and points are tied, the winner will be determined by what ever tie breaker the judge decides upon. If a dog (or handler \odot) bites, steps on, or runs over a duck, the run is over but the team will maintain whatever points they earned up until that point.

If there are additional day of entries available for the "Duck Off" each team may enter additional times for a discounted entry fee. The additional runs will not count towards the class placement but is a great way to get additional practice in.

This is a FUN event. Please enter your dog into the appropriate class level. (i.e. if your dog does not have a title but is trained past the started level please enter them in a higher level). All decisions by the judge will be final.

Sunday Dec. 16th

• AHBA Trial: Check in 8 a.m. to 8:15 a.m. Handler's meeting at 8:30 a.m. AHBA rules will apply. Maximum of 24 runs. Head per run: 5 ducks.

FEES: AHBA \$20.00 pre-entry \$25.00 day of entry

All pre-entries must be postmarked on or after October 29, 2012 thru December 9, 2012 No pre-entries will be accepted with a postmark before October29th

Sorry, no phone or email entries!

Please state clearly on each entry form which dates/ trials and what classes you are entering. Please use an ASCA entry form for the ASCA event and an AHBA entry form for the AHBA trial and the Duck

Off entry form for the Aussie Rescue event.

All non-aussie entrants must be registered with a tracking number from ASCA to receive titles. See ASCA website for details. You may also register for a tracking number at the trial. www.asca.org

Entries will be accepted in postmark order. In the case of duplicate postmark entries a random draw will be made of those entries to determine the order of acceptance. Run order will be drawn on December 14th. Correct entry fee must accompany an official, signed, and FULLY completed entry form (s) to be considered a valid entry. AHBA, ASCA, and the Duck-Off forms are included in this flyer. ASCA Forms are also available on the ASCA website. www.asca.org. AHBA forms are also available on the AHBA website, www.ahba-herding.org. Day of show entries will be allowed if space is available. A waiting list will be established if the trial fills. Entry fees will only be refunded if the trial AND your spot is filled. Bitches in heat will run in the order of the draw.

- 2. EXHIBITOR AND OWNER CERTIFY THAT THE ENTERED DOG IS NOT A HAZARD TO PERSONS, DOGS OR PROPERTY.
- 3. EXHIBITOR AND OWNER ACKNOWLEDGE ALL HAZARDS PRESENTED BY THE EVENT AND THE EVENT PREMISES, INCLUDING, BUT NOT LIMITED TO, THE CONDITION OF THE FLOORS, STAIRWAYS, HALLS, LIGHTING, SECRUITY MEASURES OR LACK THEREOF, ELECTRICAL APPLIEANCES, SHOW RINGS. PARKING AREASA AND THE PRESENCE OF UNFAMILIAR ANIMALS AND PEOPLE: EXHIBITOR AND OWNER ASSUME THE RISK OF ANY HARM ARISING FROM THESE.

All dogs nine months of age or older are eligible to participate in Herding trials and JHD. Dogs classified as Herding Dogs in AHBA are eligible for HERDING TEST (HCT). No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test/trial. Bitches in season shall run in drawn running order without adjustment.

AGREEMENT

I (We) acknowledge that the "Rules Applying to Registration and Dog Shows" and the "Regulations for Herding Tests and Herding Trials" have been made available to me (us) and that I (we) agree that the club holding this herding test or trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and the holding of the Herding test or Trial and opportunity to have the dog tested or judged and to win prize money, ribbons or trophies, I (we) agree to hold this club, it's members, directors, governors, officers, agents, superintendents, or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the herding test or trial premises or grounds or near nay entrance thereto, and I (we) personally assume all responsibility and liability for any such damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any person or any other causes. I (we) hereby assume the sole responsibility for and agree to indemnify and hold the aforementioned parties harmless from any and all losses and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting herefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property arising out of or in consequence of my (our) participation in the Herding Test or trial, howsoever such injuries, death or damage to property may be caused, and whether the negligence of the aforementioned parties or any of their employees or agents, or any other persons.
