Grooming and crating will be indoors adjacent to the ring, on protective covering.

Limited/shared electricity available.

Indoor crating for obedience and rally will be available on concrete.

**NO CHALKING.**

**THANKS FOR CLEANING UP AFTER YOUR DOGS AND YOUR SET-UP.**

There will **NOT** be a food booth. Fast food restaurants are nearby, on Lyndale & Am Blvd.

There will be NO electricity for RV amenities. No Camping on site.

Show grounds will be available at 7:00 AM on both Saturday and Sunday

A photographer MAY be available for win shots.

Conformation entries for each show shall close at the gate entry deadline, as stated on the front of the flyer, which will be prior to the judging of the first class of that show.

Directions to Veterinary Clinic: West on 82nd Street to 35W, North on 35W to 494. West on 494 to Hwy 212 Exit, follow Shakopee/Chaska Signs, right at stop light (Flying Cloud Drive), right at 3 rd driveway.

No entry shall be accepted from a dog or handler disqualified from ASCA's Conformation, a dog or handler disqualified from all ASCA programs; or a person NOT in good standing with ASCA.

All dogs six months of age or over at the show site must have a current rabies vaccine certificate in their owners' possession.

All Australian Shepherds six months of age and older must be able to show proof of ASCA registration to be eligible for showing

Dogs showing threatening behavior will be subject to either disqualification or excusal, per the ASCA Dog Bite Policy. All UMASC investigations and appropriate forms will be forwarded on to the ASCA Business office. Dogs excused or disqualified under said policy, will be excused from the remainder of the events and asked to leave, without refund of entry fees.

Dogs **appearing** to show clinical symptoms of distemper, infectious hepatitis, parvovirus, leptospirosis, kennel cough or other communicable diseases will be **asked to leave the event, without refund of entry fees.**

#### ROUTES TO BLOOMINGTON OBEDIENCE TRAINING CLUB

From the East: Go west on 494 to Lyndale Avenue Exit. Left (south) on Lyndale to 82nd Street. Left (east) on 82nd Street to Pleasant Ave. Left on Pleasant Avenue to 8127 Pleasant Avenue South.

From the West: Go east on 494 to Lyndale Avenue Exit. Left (south) on Lyndale to 82nd Street. Left (east) on 82nd Street to Pleasant Ave. Left on Pleasant Avenue to 8127 Pleasant Avenue South.

From the North: South on 35W to 82nd Ave Exit (just south of the 494 & 35W interchange), Left (east) on 82nd Street to Pleasant Ave. Left on Pleasant Avenue to 8127 Pleasant Avenue South.

From the South: North on 35W to 82nd Ave Exit (just prior to the 494 & 35W interchange), right (east) on 82nd Street to Pleasant Ave. Left on Pleasant Avenue to 8127 Pleasant Avenue South.
